*Effective July 1, 2019, in accordance with MN Statute 62J.812, all family medicine, general internal medicine, gynecology, or general pediatrics providers are required to maintain a list of the services over \$25 that correspond with their 25 most frequently billed CPT codes including: 1) the ten most frequently billed evaluation and management codes (99201-99499), and 2) the ten most frequently billed preventive services (99381-99429). The list must be updated annually (including any changes to the most frequently billed) and is to be posted in the lobby and on the provider’s website.
